The Catalogue officially came into effect on January 1, 2025, and the previous version published in the Ministry of Commerce and General Administration of Customs Announcement No. 66 of 2023 was concurrently repealed.

What does the general administration of customs (GACC) do?

The General Administration of Customs (GACC) is responsible for managing the import and export of goods and services. GACC's key functions include managing customs regulations, duties and tax collection fees, as well as port customs clearance work.

What happened to customs announcement 64 of 2023?

When does the 'catalogue of goods subject to export license administration' take effect?

This announcement and the 2025 edition of the "Catalogue of Goods Subject to Export License Administration" took effect from January 1, 2025. The Ministry of Commerce and General Administration of Customs Announcement No. 65 of 2023 was concurrently repealed.

What does a customs officer do?

Implements customs inspection of transport vehicles, goods, articles, animals and plants, food, cosmetics, and personnel; manages logistics; supervises import and export exhibits; restricts prohibited products; and manages disposal of port waste and precursor chemicals.
