Are new solar panels tax deductible in Thailand?

Only new, Thailand-certified equipment with a 5-star energy label qualifies for the 150% business tax deduction. Second-hand or imported devices are excluded from this enhanced benefit, helping ensure quality and compliance. The permit-free, online notification process for residential rooftop solar is scheduled for late 2025.

What are the tax exemptions for electricity production in Thailand?

It is important to note that the production of electricity or steam from waste or refuse-derived fuel has been classified as an activity of special importance and benefit to Thailand. Therefore, any projects who undertake activities within this field will be granted 8-year corporate income tax exemptions.
